Memorandum of Understanding for Conducting NSQF Level 4 in Mushroom Cultivation

A Memorandum of Understanding (MOU) is made and executed on this ^{1st} Day of *May*, 2018.

BY AND BETWEEN

Mizoram Skill Development Society(MSDS), 100% owned by the State Government and registered under Society Registration Act at A36-SL Sailova Building, Upper Republic, Aizawl – 796001 of the **FIRST PART.**

Principal, Pachhunga University College, College Veng, Aizawl – 796005 (hereinafter referred to as “Second Party” which expression shall, repugnant to the context or meaning thereof, be deemed to include its representatives) of the **SECOND PART.**

I. Purpose and Scope

A. The purpose of this Memorandum of Understanding(MOU) is to engage a Facility Provider to fulfill, successfully execute the obligation of MSDS identified and arising out of its Agreement with NSDC in accordance with the requirement, rules and parameters laid down by the respective authority for VOCATION SKILL DEVELOPMENT TRAINING. Such Facility Service Provider shall be known as “Authorised Facility Provider “.

B. MSDS is vested with necessary expertise in rendering on its own or through its Authorized Collaborator-Education, training, training support, preparing course plan, teaching plan, teaching and training modules etc.

C. The Second Party having understood the requirement of Vocation/Skill Development Training, obligations as to a “Authorised Facility Provider” has assured MSDS that it is vested with necessary infrastructure in rendering on its training facilities.

D. MSDS based on the representations and warranties of the Second Party has decided to engage the Second Party as its “Authorised Facility Provider “ for providing the required infrastructure, which the Second Party has read and clearly understood.

E. Both parties have ensured each other that the various activities are conducted and shall be conducted in future in compliance with all applicable and existing laws, rules, and regulations. The decision of MSDS in this regard would be binding upon both parties.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS HEREUNDER :

I. MOU Term

The term of this MOU agreement is the period commencing from...¹... day of *May* 2018 and shall automatically expire on or before ³¹... day of *Dec*, 2018.

II. MSDS Responsibilities:

1. MSDS shall provide the content, curriculum and study material for the course listed in Annexure I.
2. MSDS shall upon information always be ready and willing to support, help and assist in case of any difficulty arising out with execution of the obligations/ scope of work.
3. Coordinate with NSDC/SSC for admission, training, MIS, assessment certification and payments.
4. Shall completely be responsible for the Project Management and Project Monitoring activities.
5. A sum of R.25000.00 shall be paid to Resource Person(s), 10000 to Trainer(s) as an Honorarium.

III. Authorized Facility Provider Responsibilities:

Second Party shall perform the various obligations of MSDS arising out of its infrastructure including but not limited to :

1. Availability of Laboratory/s and required infrastructure at the location as per the guidelines of NSDC/SSC .
2. Arrangement of qualified Resource person(s)/Trainer(s) as per the guidelines of NSDC/SSC..
3. Compliance with the various applicable laws, regulations.
4. To ensure safety norms at the centre.
5. There should be one chair for one candidate. It should have enough space for sitting along with arm for writing and space. In case table – bench arrangement at least 2 ft. Space of bench should be available for each student.

6. There should be one trainer chair and trainer table of adequate size in the academic rooms.

7. There should be enough light and air in the class rooms and lab.

8. Domain related equipment's as per the specification given by the SSC should be installed in the training center.

9. The Facility Provider should ensure that all equipments tools, computers , Net connection, power backup system required for the skill training programme are perfectly functional through the course of the training.

11. Clean and purified drinking water should be available for the candidates in training centers throughout the working hours. The Facility Provider should also keep first aid box at the training center.

IV. Mobilization of Beneficiaries

MSDS will bear the cost for mobilization of beneficiaries, however it will be a joint responsibility of both Parties in mobilization drive.

V. Modification and Termination

1. This agreement may be cancelled or terminated by either party by giving a written notice of Thirty(30) days.

2. Any and all amendments must be made in writing and must be agreed to executed by the parties before becoming effective.

VI. Severability

That, each and every obligation under this MOU shall be treated as a separate obligation and shall be severally enforceable as such and in the event of any obligation or obligations being or becoming unenforceable in whole or in part, to the extent that any provision or provisions of this MOU.

MOU terms are if unenforceable and they shall be deemed to be deleted from this MOU, and any such deletion shall not affect the enforceability of the reminder of this MOU not so deleted provided the fundamental terms of the MOU are not altered.

VII. Execution

That, this MOU may be executed in one or more counterparts including counterparts transmitted by facsimile, each of which shall be deemed an original, but all of which signed and taken together, shall constitute one and the same instrument.

VIII. Assignment

That are the obligation of second party under MOU shall not be capable of assignment unless MSDS allows it in writing under exceptional circumstances

XI. Termination

BY FIRST PARTY: Without prejudice to any other right of termination or remedies which the First Party may have under this agreement, the Second party acknowledges and agrees that the occurrence of any one of the following events shall constitute an Event of Default under this Agreement by the Second Party and First Party may, in its sole option, terminate this Agreement by written notice to the Second Party:\

- a) The Second Party abandons or fails to fulfill its obligation under this MOU;
- b) The Second Party violates any Applicable Law;
- c) The Second Party assigns its obligation under this MOU without prior written confirmation from the First Party;
- d) The Second Party (or any of its partners/Principal/Head of Department) engage in any dishonest or unethical conduct which in the First Party, 2 opinion may adversely affect the reputation of the First Party;
- e) The second party closes the infrastructure usage without prior notice of First party.

BY SECOND PARTY ; If the Second Party has not been in breach of any of the provisions of this Agreement and the First Party materially fails to comply with the provisions of this agreement and does not cure such failure within thirty(30) days after written notice of such material failure is delivered to the First Party, the Second Party may terminate this agreement effective thirty(30) days after delivery to the First Party of written notice of termination. The Second Party may not terminate this agreement for any other reason or without such notice.

X. Exclusivity of Execution

The " Authorised Facility Provider" cannot enter into any other agreement or execution of any program under the same Sector skill council for which this MOU is executed till 3 months from completion or termination of this MOU by either side. Further the " Authorised Facility Provider " cannot execute the said training, as mentioned in this para, even if the " Authorised Facility Provider" and their associate is having any distant connectivity with any other organization or by their first family members or relatives and also by any mode and through any relation, at any other address within India.


XI. DISPUTE RESOLUTION
