AGREEMENT FORM

(For engagement of Provisional-employee)

Article of Agreement made on 01.05.2020 between Mr/Mrs/Ms

Whereas the Government of Mizoram have engaged the party of the first part as Lower Division Clerk had the party of the first part has agreed to serve the Government on the terms and conditions herein after contained. The party of the first part shall be entitled to a remuneration at the rate of Rs 16,920/- pm (all inclusive).

By the Competent Authority if the party of the first part commits any misconduct (including indiscipline, insubordination, negligence of duty or criminal act, etc) or of any breach of any provision of these presents or of any rules pertaining to the office of the public service in which he/she served.
